Inspecting Children's Playgrounds Training Course Checklist

The following checklist is to help you ensure that everything is in order for the day. The timing is usually 9.00/9.30am to 3.30/4.00pm. Because of the importance of the practicals, the maximum number per course is around 12 persons.

(please tick as appropriate)	
	A room that can be reasonably darkened is desirable for purposes of clarity of Powerpoint presentation
	Screen or light coloured, flat, wall
	Electric socket for projector – An extension lead will probably be needed if it is not in a convenient position
	Flipchart/pens (or white board with markers)
	Refreshments (liquid mid-morning/afternoon and probably arrival). It is also best if lunch is at the venue (buffet/sandwiches) - wandering off tends to be disruptive
	At least 2 playgrounds to inspect (these should be chosen on the basis of a reasonable variety of equipment, showing signs of wear/deterioration/ damage)
	Transport to the playgrounds (or agreement that people will take their own cars)
	The playgrounds will not have fairground/community event on the training day. If it is a holiday period the playgrounds are NOT ones that are likely to be packed with children on that day
	Any permissions or courtesy notifications with managers/owners of specific playgrounds have been obtained/sent
	Attendees have been informed that there is a practical inspection; they may have to go up a climbing frame/multi-play, or it may be muddy/raining, so they should wear appropriate clothing and footwear
	The budget quotation for an in-house, one-day course is £850.00 plus VAT inclusive of all expenses and delegate packs. This assumes that the customer provides the venue, refreshments etc. Delegate based training will cost £130.00 plus VAT per delegate. (Jan.2018)
